Our forms are subject to change; generally this occurs three times a year with fixed dates of April, July and November.

However, in certain circumstances there may be a requirement for publishing forms outside of these dates. Prior to submitting any application you should ensure that you have completed the most current form.

A Visa Application Charge (VAC) is the amount of money, in Australian dollars (AUD) that must be paid for most visa applications to enter Australia. The VAC is generally not refundable even if the visa application is unsuccessful.

VACs are reviewed on 1 July each year and this may increase the cost of a visa application.

If the VAC is changed, the new amount will apply to all visa applications received by the department on and after the day the VAC is changed.

Method of Payment

Payment **MUST** accompany your application. To make a payment, please pay by Bank Draft addressed to any bank in Islamabad, made payable to the 'Australian High Commission, Islamabad'. Please do not pay by cash, personal cheque or credit cards. Applications are **ONLY** accepted through mail or courier service.

Important: An application is not valid until the appropriate total fee has been paid.

What is an ETA?

An ETA is equivalent to a visa, but there is no stamp or label in your passport and there is no need for you to visit an Australian diplomatic office to submit an application. Applications for ETAs can be submitted through travel agents or airlines.

Now, you can also submit applications directly through this web site by clicking on the **Apply for ETA** button and, in most cases, we will be able to approve your ETA in less than 30 seconds. You can also check your ETA status, if you applied through this site, by clicking on the **Check your ETA** button.

The ETA is issued electronically by a computer system operated for the Department of Immigration And Citizenship (DIAC) of Australia.

When an application for an ETA is submitted through this site, all you need to do is enter the details from your passport and your credit card information. The application is processed immediately. Approved applications are electronically recorded on Australian Government systems.

When you arrive at an airport for check-in on a flight to Australia, the airline check-in staff can electronically confirm that you have authority to board the flight to Australia.
