- Letter of the employer mentioning monthly salary earned by the applicant
- Recent passport size photograph (white background-non glossy paper)
- Passport should be valid for at least 6 months
- Bank Statement of the last 6 months. (Bank account maintaining certificate required). Bank Statement should not be older then 10 days.
- Original NTN, Chamber's Certificate, Import Export License and Company Registration. **With last tax returns for 3 years (compulsory)**
- Documentation of socio-professional standing
- Travel Insurance
- Family Registration Form From Nadra
- Confirmed hotel reservation/offer of hospitality along with payment receipt confirmation
- Nikha Nama required in English Translation if applicant applying with wife
- Original Ticket along with payment receipt confirmation
- Copy of CNIC with English Translation
- All Passports issued by birth and all valid visas copies

# **Business Visa Requirements:**

- Covering Letter of the firm
- Letter of invitation by the Italian counterpart addressed personally to the
  applicants, specifying the reason of the invitation, the period of stay, and clearly
  mentioning that "the Italian company is fully aware of the Italian legislation in
  the field of immigration, and in particular of the penal and civil responsibilities
  deriving from the violation of such laws " in addition to its Chamber of
  Commerce registration
- Recent passport size photograph (white background-non glossy paper)
- Passport should be valid for at least 6 months

- Bank Statement of the last 6 months.( Company & Personal) .( bank account maintaining certificate required)
- Proof of financial funds available of the applicant for the period of stay in Italy (traveler's cheques, credit cards)
- Contract of Employment or salary slip
- NTN, Chamber's Certificate, Import Export License and Company Registration. With last tax returns for 3 years (compulsory)
- Documentation of socio-professional standing
- Travel Insurance
- Family Registration Form From Nadra
- Confirmed hotel reservation/offer of hospitality along with payment receipt confirmation
- Original Ticket along with payment receipt confirmation
- Copy of CNIC with English Translation
- Filling in of the Company profile
- All Passports issued by birth and all valid visas copies

Processing time: 15-20 working days for the approval of visa from the immigration.
