## Tourist Visa Requirements

Documents to be submitted together with an application for tourist visa:

- (1) Passport (valid for at least six months).
- (2) Recent Police Certificate (in original) duly attested by the Ministry of Foreign Affairs of Pakistan.
- (3) Confirmed return ticket, (computer printout is not accepted).
- (4) Confirmed hotel reservation, emanating from the hotel itself and addressed to the Consular Attaché, Mauritius High Commission, Islamabad (Fax No. +92-51-2824656).
- (5) Photocopy of applicant's passport (first five pages).
- (6) Photocopy of ticket (date of entry and departure from Mauritius).
- (7) Two passport-size photographs of the applicant.
- (8) Proof of funds to meet the cost of stay in Mauritius (at least US \$ 100 per day), supported by original up-to-date bank statement, with covering letter from Bank authorities.
- (9) National Identity Card and copy thereof.

## **Business Visa Requirements**

Documents to be submitted together with an application for business visa:

- (1) Passport (valid for at least six months).
- (2) Recent Police Certificate (in original) duly attested by the Ministry of Foreign Affairs of Pakistan.
- (3) Confirmed return ticket, (computer printout is not accepted).
- (4) Confirmed hotel reservation, emanating from the hotel itself and addressed to the Consular Attaché, Mauritius High Commission, Islamabad (Fax No. +92-51-2824656).
- (5) Invitation letter from business counterpart in Mauritius, indicating the
- (6) Registration Certificate from Chamber of Commerce & Industry.
- (7) Photocopy of applicant's passport (first five pages).
- (8) Photocopy of ticket (date of entry and departure from Mauritius).
- (9) Two passport-size photographs of the applicant.
- (10) Proof of funds to meet the cost of stay in Mauritius (at least US \$ 100 per day), supported by original up-to-date bank statement, with covering
- (11) National Identity Card and copy thereof.
