Tourist Visa Requirements

Documents to be submitted together with an application for tourist visa:

- (1) Passport (valid for at least six months).
- (2) **Recent Police Certificate (in original) duly attested by the Ministry of Foreign Affairs of Pakistan.**
- (3) Confirmed return ticket, (computer printout is not accepted).
- (4) Confirmed hotel reservation, emanating from the hotel itself and addressed to the Consular Attaché, Mauritius High Commission, Islamabad (Fax No. +92-51-2824656).
- (5) Photocopy of applicant's passport (first five pages).
- (6) Photocopy of ticket (date of entry and departure from Mauritius).
- (7) Two passport-size photographs of the applicant.
- (8) Proof of funds to meet the cost of stay in Mauritius (at least US \$ 100 per day), supported by original up-to-date bank statement, with covering letter from Bank authorities.
- (9) National Identity Card and copy thereof.

Business Visa Requirements

Documents to be submitted together with an application for business visa:

- (1) Passport (valid for at least six months).
- (2) **Recent Police Certificate (in original) duly attested by the Ministry of Foreign Affairs of Pakistan.**
- (3) Confirmed return ticket, (computer printout is not accepted).
- (4) Confirmed hotel reservation, emanating from the hotel itself and addressed to the Consular Attaché, Mauritius High Commission, Islamabad (Fax No. +92-51-2824656).
- (5) Invitation letter from business counterpart in Mauritius, indicating the nature of business.
- (6) Registration Certificate from Chamber of Commerce & Industry.
- (7) Photocopy of applicant's passport (first five pages).
- (8) Photocopy of ticket (date of entry and departure from Mauritius).
- (9) Two passport-size photographs of the applicant.
- (10) Proof of funds to meet the cost of stay in Mauritius (at least US \$ 100 per day), supported by original up-to-date bank statement, with covering letter from Bank authorities.
- (11) National Identity Card and copy thereof.

Kindly note that:

- (a) Applications should be sent to the High Commission by **Courier Service only**, provided:
 - (i) all the necessary documents are enclosed with the application;
 - (ii) the confirmed hotel reservation has been received at the High Commission (e-mails are **not** accepted).
- (b) The High Commission may request further information/documents from the applicant in addition to those mentioned above.
- (c) Applicants should refrain from making repeated telephone calls to enquire on the status of their respective applications. This could further delay the processing of applications.
- (d) After processing the application, the passport & ticket will be returned by **Courier Service (Cash on Delivery)** at the applicant's risk.
- (e) **The High Commission of Mauritius in Islamabad reserves the right to refuse the issue of a visa without giving reasons, whatsoever.**
